

# Booking your Trip

Before making a booking please ensure you have read the document "Commitment's Style of Sailing".

You should then contact the Team Mowbray Pty Ltd office, either by email [tony@tonymowbray.com.au](mailto:tony@tonymowbray.com.au) or telephone +61 (0)2 49 458256 or Mobile +61 (0)428 653071 to check availability. Once we have confirmed availability you need to send us a completed and signed Booking Form.

To secure your berth a deposit of 1/3 of the total fee is to be paid with booking. Another 1/3 payment is due four months prior to departure with the final 1/3 payment due no later than 6 weeks before departure date.

All payments are in effect non refundable. If it becomes necessary for you to cancel your trip you must notify us in writing. Cancellation more than 4 months before departure forfeits the deposit, between 4 months and 6 weeks 2/3s is forfeited. Less than 6 weeks before departure total fee is forfeited.

If multiple trips are booked and a passenger's behaviour is deemed to be inappropriate, disruptive or impinging upon the other passenger's enjoyment of their trip then, at the skipper's sole discretion the passenger will be asked to leave the vessel at the earliest reasonable opportunity and all monies paid including those for any unused trips will be forfeited in full.

Personal travel insurance is not included in the trip price.

We strongly recommend that you take out personal travel insurance that includes trip cancellation insurance in the event of cancellation by yourself.

Team Mowbray Pty Ltd and the Skipper of "Commitment" reserve the right to alter itineraries without notice due to unfavourable weather, political unrest or any other situation beyond our control.
